## Whip'r Snapper Board Meeting

### February 18, 2023 @ Pam Miller-Mitchell's home in Lake View Terrace, CA

In attendance were Diane Kern; Secretary, Katie Twohy; Treasurer, Marc DiLeo, Lori Weiss, Pam Miller-Mitchell and Kate Aparicio. Also present were Ted and Veronica Campbell and Erin DiLeo.

The minutes from the Annual Meeting were approved as published.

### Treasurer's Report:

Katie Twohy reported the balances as of 1/31/2023 were: Checking; \$1,102.24 which included a transfer of \$500 from savings to avoid a fee. Savings \$4012.24.

Income of \$90 came from membership and newsletter ads.

### Membership Report:

Diane Kern brought up the issue of clarifying the family membership. It was decided that all people residing in the same household would constitute a family no matter their age. Lisa Blank sends out a reminder to all who need to renew their membership and has a page in the newsletter clarifying member renewals. Anyone who has a question can contact her directly. Occasionally in the past members have paid too frequently for multi year memberships. [Lisa B. has said that the overpayments have been cleared up and almost no one seems to pay over the minimum requirement.]

### 2023 Events:

# March 18, 2023; Shamrock ADT (Arena Driving Trial) at Grey Stone Ranch in Phelan, CA

Marc DiLeo reported on the upcoming ADT in Phelan. He has a goodly number of volunteers but experienced driving knowledgeable volunteers are needed to augment the helpers who have not judged a driving event. There will be four different obstacles with some distance between them. Marc is planning a practice run-through to get his helpers up to speed. Lori Weiss suggested drivers who are not entered could go out and drive for the practice run-through.

He is planning an 8 A.M. drivers meeting. Due to the layout of the property the entrance gate will be closed to cars and trailers at about 8:30. After that time any parking will need to be on the dirt roads outside the venue. There will be no in and out traffic during the day, so bring your bikes and golf carts.

Marc has collected about \$300 in sponsorship money. The Pitzlers are donating the venue. Thank you Diane and Wayne! Not too many entries are in hand but they usually come in at the last minute.

### **Board Business:**

Elections: Pam Miller-Mitchell moved to re-elect Jennifer Russell as President, Katie Twohy as Treasurer, Diane Kern as Secretary and Marc DiLeo as Vice-President. The motion passed unanimously.

Meetings: The first Wednesday of every month at 6:30 was proposed for a regularly occurring board meeting via Zoom/conference call. N.B. The first 40 minutes of Zoom is free then charges apply. Our conference call service is not free but the cost is usually under \$20 or \$30 if people use the toll free number. Katie Twohy will check with USDFD to see which free service they use for their meetings. Some services have connection/audio issues but we have not had trouble with Conference Unlimited. All present agreed on the day and we will make sure the board members not in attendance do not have a conflict. An in person board meeting will be attempted at least once a quarter.

**By-laws:** Marc DiLeo suggested a committee to review the by-laws which were last updated by Teresa Camarillo in 2011. Katie Twohy will send out a copy of the current by-laws to all board members. No action will be taken until everyone has a chance to read the by-laws. Verification that the by-laws state that we haave an educational purpose would be required if we change to a 501(c)(3).

501(c)(3): Marc DiLeo suggested we change from a 501(c)(7) to a 501(c)(3). The advantages would be that donations would be tax deductible. He has been told that the paperwork could be done for \$500. It is a state application to change the status and possibly the club would need to incorporate. An audit by three members and/or a CPA might need to occur annually and additional tax filing paperwork would be involved. Katie Twohy noted that changing back to a 501(c)(7) or closing the club would require donation of all funds back to another 501(c)(3) or to the government.

Pam Miller-Mitchell and Diane Kern noted that we didn't have an easy time getting donations for shows. It didn't seem to matter that we were not offering a tax deduction. Stores were just not interested even when we could show them the ads they could have in the very nice program Veronica Campbell produced for Pleasure Days.

### Treasurer's Report:

**Insurance:** Jennifer Russell reported that the insurance is due in April. The exact price is unknown at this time but will be approximately \$2,200 to \$2,600 for the club insurance and the officers and directors coverage.
